





## Meraki Licenses





### Licensing is required and includes:

- Centralized management and networkwide visibility and control
- Seamless firmware and security updates
- Phone support and lifetime warranty (for most devices)


## Meraki Device Licensing Types

- The MR and MV devices only have one license type, a general device type license. This license can apply to any device of that specific type (EX: MR, MV), so long as there is one license for every device in the account. For example, a network containing 1x MR57 and 1x MR56 will require licensing for 2x APs.
- The MX and MS devices have licenses on a per-model basis, so every MX and MS model has a corresponding license. Please note that these licenses are nontransferrable between appliance models. For example, an MS355-24 will not be covered by an MS355-48 license; it will require an MS355-24 license.



## **MX** Appliance Licensing

The MX line has three tiers: Enterprise, Advanced Security, OR Secure SD-WAN PLUS.

## **MS** Licensing

The MS line has two tiers: Enterprise **OR** Advanced. The Advanced Licenses are only available for the **MS390**.

## **MR** Licensing

MR Enterprise + MR Upgrade = MR Advance



Meraki Wireless devices can be licensed in a few different ways. It line has three license types: Enterprise, Advanced, and Upgrade Licenses.



The MR **Enterprise** license is the standard license and covers everything but Umbrella capabilities. That is where the Advanced and Upgrade Licenses come in.



The MR **Upgrade** license is considered an add-on license and enables Umbrella functionality and Adaptive Policies only. It can only be assigned to MR access points with an active device (Enterprise) license. This license is generally purchased for MR access points that already have a basic enterprise license.



The MR Advanced license includes a device (Enterprise) license for an MR access point itself in addition to the Umbrella/Adaptive Policy add-on license which enables Umbrella and Adaptive Policy functionalities on that access point. This license is generally purchased for licensing a new MR access point that does not already have a license.

## **MV** Licensing

- 1:1 license to hardware model
   <u>LIC-MV-(1, 3, 5, or 7 Year)</u>
- 16 models, but only one license SKU
- 5 year warranty on all new models

## Meraki Licensing Models

Meraki currently offers types of licensing models:

- Co-Termination Licensing (Co-Term)
- Per-Device Licensing (PDL)
- Subscription Licensing

All Meraki current and new customers will be using a co-term licensing model by default.

- Per-device & Subscription licensing is available for all new and existing customers to opt into.
- If you wish to be on PDL, you can opt-in by having Meraki Support enable it after creating your organization.
- If you wish to be on Subscription, you can opt-in from the License Page.



## **Co-Termination Licensing**


### What is Co-termination?

- Meraki co-term licensing is applied on an organization-wide basis, resulting in a single expiration date for every Meraki device managed in an organization.
- This means that a license isn't purchased for a specific serial number or device, rather each license added to the Organization increases the number of a specific device type (the License Limit) that can be added to Networks within the Organization.
- That date is dynamically calculated based on a weighted average of the license types purchased and claimed into your dashboard organization. This is accomplished by averaging all active licenses together and dividing by the License Limit, or allowed count of Meraki devices in the organization.
- The single expiration date for all Meraki devices in that organization is dynamically re-calculated (by the Meraki dashboard) with each license and hardware claim.

# When do my licenses activate?

 Licenses in the Co-Termination model start consuming time from the date it was processed, not the date they are added to an organization

## **Co-Term Licensing: Calculator**

- Given the co-terminating nature of Cisco Meraki licensing, it can be helpful to understand how a new license will affect your cotermination date before it is applied.
- The License Calculator can be used to simulate licensing states and calculate a projected co-termination date.
- The co-termination date is calculated based on several components including the base price (dollar value of each license) and remaining days (amount of time remaining on the existing licenses).




## Out of Compliance - 30 Day Grace Period

- There will be a 30 day grace period from the time that the license expires and the device or product shuts down.
- If the customer keeps the expired device in the network, when they apply a new license, they will 'lose' the time from the newly applied license from how long they were in the grace period.




## Per-Device Licensing

What is Per-Device Licensing?

- Cisco Meraki's per-device licensing model allows customers to assign a license directly to a specific device or a network. This allows IT teams to maintain a single shared expiration date or various expiration dates across devices, networks, or organizations.
- Per-device licensing offers a variety of features and ultimate flexibility for customers of all sizes. Per-Device Licensing








## **Per-Device Licensing**



- License Devices Individually: Assign a license to a specific device (MR, MS, MX, MV, MG) or a network (in the case of vMX and SM licenses) and maintain a shared expiration date or separate expiration dates across devices, networks, or organizations.
- Partial Renewals: Enjoy the ability to renew all your devices, or a subset of devices as you prefer.
- 90-Day License Activation Window: You will have up to 90 days to claim and assign your licenses before they activate – giving you more time to deploy Meraki products before your licenses burn time.
- APIs: APIs are available to claim, assign, and move licenses. This will allow a greater level of automation and the ability to integrate with other systems.
- Individual Device Shutdowns: If a license expires on a device, Meraki will only shut down that device or product (after the 30 grace period)


Process and how a customer orders licenses *does not* change in per-device licensing



Customer claims license key/order # in organization


